I am writing to support the city's nomination for placing Hobbs Park on the local historical register. As you know, Old East Lawrence already has two designated historic districts, and yet another will be sought with the redevelopment of the 800 Block of Pennsylvania Street. We also have various individual buildings listed, such as St. Luke AME Church.

As a past president of the East Lawrence Neighborhood Association (ELNA), I have been a long-time supporter of the Hobbs Park project — as preservation is one of the principal objectives of our neighborhood plan. Personally, and professionally, I can see many advantages this designation has for the neighborhood.

To begin with, I feel we need to remain attuned to the importance that the neighborhood, Lawrence and the state play in our country's long fight for civil rights and equality. The designation is a reminder of our commitment to these ideals, the sacrifices they require, and the vigilance they demand.

At the same time, all these districts, and the environs rules they invoke, are one of the best tools for maintaining the particular character of this neighborhood. Most of our homes are simple, vernacular dwellings that, while increasing in value like all of Lawrence, are still relatively more affordable than other neighborhoods, especially those adjacent to our downtown.

For 150 years, people in this neighborhood have built, added to, or remodeled these modest houses, using sweat equity as their means for creating a home and stabilizing the neighborhood. Old East Lawrence still offers apportunities for people who cannot necessarily afford to purchase their dream home as a "finished product."

I am confident that a historical designation at Hobbs Park will only enhance this phenomenon. As a homeowner, and realtor, living within the proposed environs, I truly don't see any negative aspects to this opportunity. I know that, at its core, the value of my property, and the equity I have put in it, rest in our neighborhood's and city's unique character. I have confidence that this nomination protects this character — and my investment.

In April 2004, my brother and I had the good fortune to be among the first people notified that 946 Pennsylvania was up for sale. Having searched for a home to buy for several months, we were elated to find one that so closely resembled our idea of the ideal house. Our offer was accepted by the previous owners, the Wards, and we closed a month later.

Since then, we have only become more aware of how lucky we are. The neighborhood is one of a kind. All of our neighbors are open and friendly, and almost everybody is aware of happenings in the community. The East Lawrence Neighborhood Association annual block party is held down the street every year, in conjunction with the Penn House, and offers a meal to anyone who attends, a free bike repair clinic, and activities for kids. These organizations exemplify the caring and open-minded spirit of the neighborhood.

I support designating Hobbs Park as a local historical site, and the inclusion of its 250' environs. Our house is among the properties that the proposed designation will affect. I believe that the historical designation can bring deserved stability to this historically rich neighborhood.

My brother and I have begun to uncover part of our house's history. Built in the 1890's or earlier, the house has impressive gingerbread ornamentation around the front porch. Our house, along with neighboring 942 Pennsylvania, appears on page thirty-eight of the book In Plain View: A photo/document of Old East Lawrence. Local legend and a July 18, 1970 Journal-World article strongly suggest that our home was involved in a police shoot-out, during that summer of unrest, as evidenced by bullet holes still present in our siding and furnace flue.

I believe that our neighborhood merits the protections and benefits that designation of Hobbs Park will bring. It has been an enriching experience to live in an old house like ours--an honor that future generations ought to be able to enjoy as well.
