Petition for Action

By my signature, as a resident and/or property owner of Old East Lawrence, of majority age, I hereby respectfully petition the Lawrence City Commission to vote in support of Harris Construction's condominium development on the 800-block of Pennsylvania Street,

ONLY if the neighborhood's integrity is respected and protected, by adoption of all or most of the following eight mitigating measures:

Placement of restrictions upon the East Bottoms C-5 Overlay District of 2006, prohibiting uses deemed unsuitable for a historic, single-family district;

Mindful that this building site is adjacent to single-family and duplex residential zoning, reduction of residential density of the proposed fifty-four condominiums to be constructed on the west side of the 800 block of Pennsylvania Street by <u>at least</u> a third. Additionally, there shall be provision for dedicated, site-planned green space, and assurance that the majoriety of units will accommodate families;

Removal eastward of planned commercial hubs from the north and south ends of the west side of the 800 block of Pennsylvania Street, with overall building height limited to two stories:

At least 20% of condominium units constructed shall be perpetually affordable housing units, bound by agreement between the City of Lawrence and the developer of record, and administered through the Lawrence Community Land and Housing Trust (LCLHT).

Public or private funding of a range of improvements to neighborhood streets, sidewalks and plantings, as well as Hobbs Park, and the New York School grounds;

Creation of some form of monument or interpretive marker explaining the important national history represented by Lawrence's old East Bottoms, which sheltered a significant portion of the city's early African American immigrants during and immediately after the American Civil War;

Provision for a public trust on behalf of the East Lawrence neighborhood, managed by the City of Lawrence, from a proscribed portion of the increased property taxes accruing from the development of the newly created multi-acre urban conservation overlay district;

Planning Department sponsorship of at least eight new residential listings from the neighborhood's north end to the Register of Historic Kansas Places, from a list of candidates presented by the Old East Lawrence Preservation Alliance.
