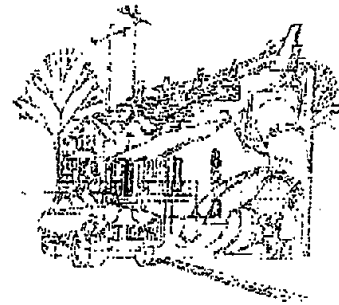

Dear Ms. Buford:


Thank you for asking us about our thoughts on the TTH affordable land trust housing development project on Bullene Avenue.
