ing the applicant to engage in or work at the business of plumbing as a master plumber. Said certificate shall be valid and have force throughout the state; and all fees received for said certificate shall be paid into the treasury of the city.

- Section 6. The fees for said examination or for the annual renewal of the certificate shall be set by ordinance passed by the governing body of the City of Kansas City, Kansas.
- Section 7. This ordinance shall be published once each week for two (2) consecutive weeks in the official city newspaper.
- Section 8. This charter ordinance shall take effect sixty-one (61) days after final publication unless a sufficient petition for a referendum is filed and a referendum held on the ordinance as provided in Article 12, Section 5, Subdivision (c)(3), of the Constitution of Kansas, in which case the ordinance shall become effective if approved by a majority of the electors voting thereon.

#### CHARTER ORDINANCE NO. 82

CHARTER ORDINANCE of the City of Kansas City, Kansas, amending Charter Ordinance No. 72; exempting the City of Kansas City, Kansas, from the provisions of K.S.A. 13-1017; and repealing said original Charter Ordinance No. 72.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF KANSAS CITY, KANSAS:

- Section 1. The City of Kansas City, Kansas, by the power vested in it by Article 12, Section 5, of the Constitution of the State of Kansas, hereby elects to exempt itself from and make inapplicable to it the provisions of K.S.A. 13-1017. Such referenced provision is an enactment or a part thereof which is applicable to this city but is not uniformly applicable to all cities.
  - Section 2. That said original Charter Ordinance 72 be and the same is hereby repealed.
- Section 3. This ordinance shall be published once each week for two (2) consecutive weeks in the official city newspaper.
- Section 4. This is a charter ordinance and shall take effect sixty-one (61) days after its final publication unless a sufficient petition for a referendum is filed as provided in Article 12,
