

This program, Movies in the Park, traditionally has been run by Parks and Recreation at South Park during the months of July and August. However this year, with the partnership, we are planning to run the program on the first Thursday night of the month Downtown throughout the summer beginning June 7 and continuing through September. We are proposing to show the movies at the corner of 9<sup>th</sup> & New Hampshire Sts. The movies would be projected on the north wall of the City parking garage, while patrons would be able to view the movie from the grass lot. We would begin at approximately 8 p.m. and would finish up by 11:30 p.m. The schedule will include film noir thrillers starring such classic actors as Humphrey Bogart and Burt Lancaster. The Downtown merchants have been very supportive and are helping with the sponsorship of this program as well.

Downtown Lawrence, Inc. has already received permission from the landowner of the corner lot and will cover movie licensing fees and additional insurance costs. They are also working with the Lawrence Police Department for security during this program. Parks and Recreation is providing the movie projector and staffing for the program.

This event would be free and open to the public.
