Accompanying this letter is an Application and Permit for Use of Public Right-of-Way from The Eldridge Hotel. The application is for temporary closing of 7th Street between Vermont and Massachusetts Street (with access to the public parking lot and alley open) on Sunday, July 15, 2007 beginning at 10:00 a.m. through 3:00 p.m. Also requested is the hooding of meters on Massachusetts Street that are directly in front of the hotel and the adjacent vacant lot.

The Eldridge Hotel will host the Kansas City Chapter of the Ferrari Club of America at their Sunday Brunch on that day. My husband Don and I are members of the Kansas City Ferrari Club Chapter and will team with The Eldridge to bring this event to Lawrence. The Kansas City Ferrari Club Chapter is a very active club of 60 members with two to three events scheduled each month. The Eldridge Hotel's Ferrari Brunch will bring an exciting Ferrari car show to Lawrence with vehicles dating from the 1960s to present. Media releases and advertisements will announce this special event.

With a decrease in sales tax revenue and the loss of some unique retail businesses, it may be our time to think of addressing Lawrence's image as a destination place not only for visitors but for our community.
