Ladies and Gentlemen:

Downtown Lawrence, Inc. would like to host an outdoor "Watch Party" for the KU-MU football game that is scheduled for November 24, 2007. We envision a free event, open to the public that might emulate the feeling of being in the open air stadium among hundreds of Jayhawk fans.

The watch party would take place in the vacant lot at the corner of 9<sup>th</sup> & New Hampshire utilizing a projector and speakers to cast the image onto the North facing wall of the New Hampshire Street Garage. We were very successful with a series of similar Film Noir screenings over the summer and we believe we have a good understanding of the logistics of such an event.

We would recruit a select number of refreshment vendors, at least one of which would hold the appropriate catering permits to be able to sell beer. We would provide two portable toilets, including one which is accessible. We would also employ two security personnel to ensure order and assist with dispersing the crowd at the end of the game.

We believe that the Downtown drinking establishments that offer game viewing will be filled to capacity and that adding this outdoor venue could help mitigate any over crowding issues. The presence of the security personnel and the vigilance of the beer vendors will help ensure a well disciplined crowd.


