Fund Description-Emergency Cell Phone Service

The Wireless Enhanced 9-1-1 Act creates a funding mechanism for improvements required to establish wireless enhanced (E-911) service. A .25¢ fee per month imposed on each wireless user account in the State for use by localities to finance E-911 improvements. The fee was enacted on July 1, 2004.

Budget Highlights

This is a new revenue source for Douglas County. The last half of FY 2004 Douglas County collected \$64,000. The 2007 budget is estimating to collect almost twice that amount.

Capital Outlay is for wireless enhanced 911 equipment.
