#### **Study Overview**


The Kansas Department of Transportation (KDOT) has initiated a transportation study focusing on the growing and changing transportation needs within Douglas, Johnson, Leavenworth, Miami and Wyandotte counties. The 5-County Regional Transportation Study has three goals: assess the multi-modal transportation needs of the region, prioritize those needs and develop strategies to address them.

Phase 1 of the study will address the first goal. It will identify the significant developments underway and/or planned in the five-county area and determine how those developments are impacting the area's transportation system. Facing increasing congestion and material costs, and reduced federal funding, KDOT wants to hear about major land developments, current and future business expansions or declines, and how residents are adjusting to changing fuel costs and environmental concerns.

The study will explore a variety of passenger and freight transportation options including car, truck, transit and train. Phase 1 is expected to be completed in late 2009. Phase 2, currently unfunded, is anticipated to begin in 2010.

"Growing transportation needs are not something that can be successfully addressed by individual communities," said Thomas Dow, State Transportation Planner, KDOT.

"A collaborative approach will benefit communities and travelers as we all face limited



funding resources. This study is challenging stakeholders to rethink transportation strategies to support community values and priorities. In the present economy, there will not be enough money to address all of the transportation needs. In order to best apply the limited resources to the unlimited needs, it is important to understand the priorities and look for new ways to solve transportation challenges."



and thinking about many points of view.
One session will be held in each of the five
counties in early 2009.


#### • Public Meeting #2 - Open House



This study is a partnership of the Kansas Department of Transportation (KDOT), the Mid-America Regional Council (MARC), the Lawrence-Douglas County Metropolitan Planning Organization, the Kansas Turnpike Authority (KTA) and the study area's counties and cities.

#### First Summit Draws Area Stakeholders

The Kansas Department of Transportation hosted approximately 150 area leaders and stakeholders for a Transportation Summit on Wednesday, December 17, 2008, at the Jack Reardon Civic Center in Kansas City, KS. The Summit was an early and significant step in the launch of the 5-County Regional Transportation Study, which applies an integrated approach for transportation planning for Douglas, Johnson, Leavenworth, Miami and Wyandotte counties.

Stakeholders heard from regional and national transportation planners as well as Kansas Transportation Secretary Deb Miller and U.S. Senator Sam Brownback. Participants contributed and discussed their own ideas about transportation needs and opportunities. The information collected will be compiled into a Preliminary Draft Needs and Opportunities Atlas.
