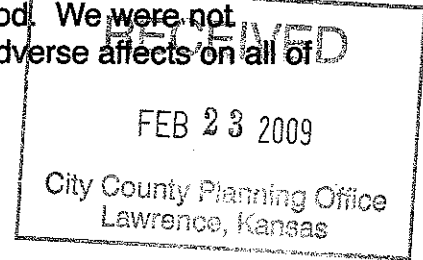


City Commision
