A 20 FOOT WIDE STRIP OF LAND, THE CENTERLINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTH LINE, 166.65 FEET WEST OF THE NORTHEAST CORNER OF LOT 10, BLOCK 2, PRAIRIE MEADOWS NO. 5, A SUBDIVISION IN THE CITY OF LAWRENCE, DOUGLAS COUNTY, KANSAS, THENCE SOUTHERLY TO A POIN ON THE SOUTH LINE OF SAID LOT 10, 96.53 FEET WEST OF THE SOUTHEAST CORNER THEREOF.
