## REPORT OF APPRAISERS

We, the undersigned, having been appointed appraisers to view and appraise the value of certain lands and/or interests sought by the City of Lawrence, Kansas, and described in the Petition in the above-captioned matter and to determine the damages to the interested parties resulting from the takings, after being duly sworn, now report as follows:

On the 28th day of May, 2009, we caused notice of our hearing to be mailed to the Plaintiff and all Defendant parties named in the Petition whose addresses were known to us after diligent inquiry, and on the 29th day of May, 2009, caused such notice to be published in the *Lawrence Journal World*, a newspaper of general circulation in Douglas County, Kansas. On June 10, 2009, we began our appraisal and assessment of damages by actual view of the lands to be taken and of the tracts of which they are a part. On the

10th day of June, 2009, a public hearing was held in the Division 5, Judge James Paddock Conference Room, Judicial Law Enforcement Center, 111 East 11<sup>th</sup> Street, Lawrence, Kansas, the time and place stated in the notice, at which time we heard oral testimony and received written and other evidence concerning our appraisal and assessment of damages from the Plaintiff and such of the Defendants as were present and desired to be heard.

After our view of the lands involved, after consideration of the testimony received at the hearing, and according to the instructions given us by the Court, we have appraised the lands and/or interests sought by the Plaintiff and described in the Petition and have determined just compensation and damages to the interested parties resulting from the takings. The damages are as follows:
