The Board of Commissioners of the City of Lawrence met in regular session at 6:35 p.m., in the City Commission Chambers in City Hall with Mayor Chestnut presiding and members Amyx, Cromwell, Dever, and Johnson present.

CONSENT AGENDA

As part of the consent agenda, it was moved by Dever, seconded by Amyx, to approve City Commission meeting minutes of October 13, 2009 and October 20, 2009. Motion carried unanimously.

As part of the consent agenda, **it was moved by Dever, seconded by Amyx,** to receive the Board of Zoning Appeals/Sign Code meeting minutes of May 7, 2009, June 4, 2009, July 2, 2009, September 3, 2009 and October 1, 2009. Motion carried unanimously.

CITY MANAGER'S REPORT:

During the City Manager's report Cynthia Wagner, Assistant City Manager, said that staff

continued to work on the acquisition of the Santa Fe Station from BNSF with the appraised

value of the structure at \$56,000. It was confirmed with KDOT that the City could still apply for

the TE Grant, even if ownership had not yet been obtained; the City's website for October

received 61,595 visits with Parks & Recreation receiving three positions in the top 10 most

visited on lawrenceks.org.; yard trimming collection saw a record number of set outs this Fall

season; and, the Community Commission on Homelessness developed "Conflict Resolution

Protocols/Guidelines" to be used for issues related to homelessness.

REGULAR AGENDA: None.

PUBLIC COMMENT:

Nicole Manriguez, a member of the Lawrence community, said there were many people

in town that were completely against the proposed ban on panhandling. The current ban was

perfect, but to ban panhandling completely would take away so much from this town.

compassion of this town was built on more than who had money. The community would be

taking away the right that "giving" was a choice of free will. Many people felt that music on the

November 17, 2009 City Commission Minutes street was important and taking away that freedom of expression, and the right to free speech, was completely unacceptable and were opposed to the new ordinance. It did not matter if one was in high dollar clothes or in clothes that had not been washed for months, it was all about the love and unity of this town. For those people on Massachusetts who were asking for a buck or two, she asked what was wrong with asking for money for help.

She said she understood aggressive conduct was the cause of problems downtown, but there was no law enforcement stopping this behavior. Now that there was less people downtown at least 4 police officers were present all day in the downtown area.

The people that came to Lawrence that stated were afraid of panhandlers, did not love this community, but came to Lawrence for KU basketball and that was not what this town was about. She said if passing this ban, a big part of the soul of Lawrence would be taken away and Lawrence would not be as beautiful and wonderful place to live any longer.

She said she strongly disagreed with the ban on panhandling and did think the ban should take place as well as many other people in the community and she felt like this issue was worth fighting for.

Dale Willis said Manriguez had a lot of good points, but he could carry any sign he wanted because this was America, as long as he did not infringe upon anyone else's rights. He said there were people fighting overseas and dying right now, for him to have the right to carry a sign. Again, it was a constitutional right and this was America.

Carmel (last name unknown) said everyone, for the most part, was nice. She liked downtown because people were doing their own thing and playing their instruments. She said even though she found panhandling pretty annoying, she liked the freedom. She said she was not obligated to give money to someone asking for money, if she did not want to.

Carly (last name unknown) said she recently moved to Lawrence to attend school, from Coffeyville, a town located at the southeast corner of Kansas on the Oklahoma border. She said their town had policies against aggressive panhandlers. She said she liked that people

were able to ask for money, cigarettes or leftovers, but no one had to give anything to anyone. Since the City already had a ban on aggressive panhandling, that ban was sufficient. The ban being proposed was not only an unnecessary measure, but harming the creativity that was a part of Lawrence.

If thinking about this issue from a sympathetic point of view, people asking for money did not necessarily have a choice and by taking away their right to ask for help and charity, was harming their personal human rights. She said from an economical standpoint, a person giving money to someone asking for money, would be helping the local economy. Part of the reason some of these people were out on the streets was because of the recession felt for nearly two years now.

Angie Shanehair said she moved to Lawrence in September to start school at KU. She said she was a street performer and played the accordion. She said from her personal experience, it had been a wonderful experience. Numerous people thanked her for playing and told her this was why they loved Lawrence. She said if the worst inconvenience for a person was turning their head the other way from a person who might not be able to eat, the City needed to re-think and prioritize what actually was important, especially with the homeless shelter and less space available for those people. The barrier between the wealthy and those who did not have enough money to buy food needed to be lessened. She said she was begging the City Commission to reconsider this issue.

Chelsea Donahue, Lawrence resident, said the current ban dealt with aggressive panhandling and she was personally in favor of panhandling, but not aggressive panhandling. She said the enforcement of aggressive panhandling was what needed to be addressed.

Michael Tanner, spokesman for the Coalition of Street Musicians, said they were in opposition of the taskforce. He said it would have a negative impact on businesses in town to make people apply for a permit to perform on the street. He said he would present a petition in opposition to this taskforce to protect their rights. (5)
