We were contacted by a subject by phone on January 31, 2009 in reference to a complaint of racial profiling. The subject was contacted by an officer in reference to an expired registration. The contact was done as a courtesy and no enforcement action was anticipated. It was later determined that due to a clerical error within the treasurer's office the subjects registration showed expired when it was in fact current. The investigation did not reveal any violation of department policy.

Decision upon disposition of complaint:

Complaint Unfounded. Subject contacted in reference to expired registration.

Action taken in response to complaint:

We were contacted a subject at the Police Department on August 12, 2009 in reference to a complaint of racial profiling. The subject was pulled over for an expired registration. Our investigation revealed that the officer could not have known the race of the driver prior to initiating the traffic stop. Again, it was later determined that due to a

clerical error within the treasurer's office the subjects registration showed expired when it was in fact current. The investigation did not reveal any violation of department policy.

Decision upon disposition of complaint:

Complaint Unfounded. Vehicle stopped based expired registration.
