

**BLUE GOOSE GOLF, LLC  
GOLF COURSE AGREEMENT**

THIS GOLF COURSE AGREEMENT (this "Agreement") is entered into as of (Date) \_\_\_\_\_, by and between BLUE GOOSE GOLF, LLC, an Arkansas limited liability company ("Blue Goose"), and EAGLE BEND GOLF COURSE, address: 1250 E 902 RD, LAWRENCE, KS 66044 ("Golf Course").

A. Blue Goose is engaged in the business of developing and marketing yardage books and scorecards to golf courses and selling advertisements which will be displayed in same; and

B. Blue Goose desires to obtain the exclusive right to design, produce and distribute yardage books and/or scorecards for the Golf Course, and Golf Course desires to obtain such products from Blue Goose to provide free of charge to its members, guests, patrons and staff, all based on the terms and conditions below.

**In consideration of the mutual covenants and agreements contained herein, the parties agree as follows:**

1. Yardage Books and Scorecards. Blue Goose agrees to provide Golf Course with the following quantities of products listed below:

10,000 YARDAGE BOOKS  
10,000 SCORECARDS

The selected product and its quantity shall be hereinafter referred to as the "Products". During the Term, Golf Course agrees to display the Products in a location within its pro shop that is readily visible and accessible to its members, guests, patrons and staff. Golf Course and Blue Goose agree that the Products shall be provided free of charge to Golf Course's members, guests, patrons and staff, and that Golf Course shall not make any indication otherwise to any third party, oral or written, during the Term. Golf Course shall notify Blue Goose within ten (10) business days of the date on which Golf Course's supply of Products is reduced to 1/3 of original supply.

2. Appointment. Golf Course hereby appoints Blue Goose as its sole designer, producer and supplier of yardage books and/or scorecards during the Term (defined below), except Golf Course may use other scorecard vendors solely for special events and tournaments.

4. Advertising. Prior to producing the Products, Blue Goose shall submit a draft copy of each advertisement to be displayed in the Products to Golf Course for its approval or rejection. Golf Course may reject any advertisement it deems inappropriate in its good faith judgment by notifying Blue Goose of such rejection within ten (10) days of receipt of the draft copy of the advertisement. Failure by Golf Course to notify Blue Goose within such ten (10) day period shall be deemed approval of such advertisement.

3. Term. Except as otherwise provided below, the term of this Agreement shall commence as of the date hereof and continue until the earlier of (i) one (1) year from the date hereof, or (ii) such time as the supply of Products has been reduced to zero (the "Term"). In the event Blue Goose is unable to obtain a sufficient number of advertisements to profitably produce and distribute the Products within ninety (90) days of the date hereof, as determined in its sole discretion, it shall immediately provide notice to Golf Course and this Agreement shall terminate.

4. Interim Supply. Upon providing notice to Blue Goose that Golf Course's supply of Section 1 above Products is low, if Golf Course and Blue Goose subsequently execute another agreement for the supply of products offered by Blue Goose, then Blue Goose shall provide Golf Course with an interim supply of the product(s) selected in Section 1 above, intended to last until such time as the products ordered under the new agreement are delivered. The quantity of interim supply shall be determined by Blue Goose in consultation with Golf Course.

3. Governing Law. This Agreement shall be construed and controlled by the laws of the State of Kansas.

7. Signature Authority. Except as otherwise provided by separate written agreement, no salesperson or other independent contractor shall have the authority (actual, apparent or implied) to execute this Agreement on behalf of Blue Goose, or to bind Blue Goose to the terms hereof.

The parties have executed this Agreement on the date first written above.
