## Hi Jonathan.

I was looking back at the previous renditions of the site plan and somewhere the lines that depicted the ROW boundaries were turned off in the CAD program.

The July 13<sup>th</sup> rendition that was sent to you, the neighbors & KU had the area your highlighted area (as well as the 700 block of West 12<sup>th</sup> street).

When KU made their requests, and subsequent site plans were released on July 14<sup>th</sup>, that boundary mistakenly was not printed.

Again, I will reiterate from the clarification letter. The 700 block of West 12<sup>th</sup> Street is within the ROW boundary for the sole purpose of allowing event participants to flow down to the Mississippi Street steps and for the Oread to administer security for the local residents and take care of trash cleanup.

The licensed premise for liquor sales will be determined by the local ABC administrator.

Attached are the correct site plans with the boundaries that correspond with the letter of clarification that was sent to you on July 13th in addition to the language that KU requested on the site plans.

I even threw in the proposed locations of the trash cans and toilets for good measure.
