These events are in conjunction with, but not limited to, National & Local Holiday(s), University of Kansas Alumni Event(s) and University Athletic Event(s).

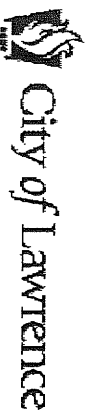
