The Outreach Team had a challenging beginning of 2010 as they experienced the loss of a team member due to budget issues, yet still attempting to meet the increased needs of people experiencing homelessness. Initiatives taken to address this include:

- 1. Developing a more systematic referral process to include an initial phone call intake and the development of walk-in office hours.
- 2. Reestablishing the Monthly Providers meeting to improve communication and connection with other community homeless service providers.
- 3. Adding a Master's level KU Social Welfare intern to the team.
- 4. Reducing the amount of information gathered and reported quarterly.

This year a new resource became available to the team as a result of federal stimulus funding. Kim Wilson Housing out of Wyandotte County assisted approximately 8-10 Douglas County families through their Housing Prevention and Rapid Re-Housing Program (HPRP).

This year the team had many discussions about the pros and cons of using the Housing Information and Management System (HMIS). In December the team was trained on the new HMIS system and will "go live" on January 17, entering information and data into this system. The plan is for future reports to the City of Lawrence to be generated from HMIS.

This year also was the year we were able to finally house someone who has been homeless fore the past 6 years.
