ITEM NO. 1: Review and approve the minutes of the Traffic Safety Commission meeting, February 7, 2011.

ITEM NO. 2: Consider request to increase the SPEED LIMIT on Bob Billings Parkway from Iowa Street to the west city limits.

Facts:

- 1. The current posted speed limit is 40 mph.
- 2. This roadway is a 4-lane facility with medians in some areas, and left-turn lanes in some areas.
- 3. Sight distance is limited in some areas due to terrain; there is at least one intersection with a recommended speed limit of 30 mph.
- 4. There are four (4) traffic signals along this roadway, but they are not coordinated.
- 5. If a vehicle were able to travel an entire mile at 45 mph instead of 40 mph, the vehicle would arrive 10 seconds sooner.
- Twenty-four-hour speed studies conducted at seven (7) locations during the period 14 April 20 April found the 85th percentile speed to be approximately 49.7 mph.

7. Raw traffic crash data shows 135 intersection crashes and 71 mid-block crashes reported to the Police Department during the three-year period 2008-2010.

Subject: Bob Billings speed limits


Crossing Lawrence takes longer than reaching Kansas City. Part of the issue is that the bypass is nonexistant and roads like 23rd/Clinton Pkwy are overtaxed. Bob Billings/15th St should be a quick way to travel from the west edge of town to Iowa St & campus. As is, the speed limits reflect a neighborhood and not a thoroughfare. I ask you consider promoting this road by giving it the speed limits a four lane road deserve.

40mph is the 'carry-through' limit from Iowa until the road terminates in west Lawrence. From Kasold to Iowa there is a divided lane. In Johnson county, these city roads would be at least 45, and likely eventually upgraded to 55mph. (Overland park - Antioch, Nall, Roe, Switzer) these roads do not have business curb cuts, or residential neighborhood entrances to excess. Turn lanes are in place. The hills will cause a vehicle (or bicycle) to exceed posted speed limits in NEUTRAL (eastbound Kasold downhill will coast a car to 44-47mph). If a bicycle can coast to a speeding ticket, you are obligated to completely redesign this section of road, remove Lawrence Ave turn lane (similar to 6th st near Dillons where a road was blocked at a light), or allow cars to move at a greater speed.

Bob Billings is free of school zones, and has two police stations. Rather than create a speed trap ticketing station near campus police, instead create a western passageway into campus. Work on extending Bob Billings west to K-10, and think of future growth.

Thank you for reading my opinion, and please communicate if I can follow up with any other advice or information. Thank you, and I do appreciate the fine roads in Lawrence (minus roundabouts which are disgraceful).

Commissioner Woods asked if the speed limit were changed, would the recommended speed at some intersections have to change; Woosley advised that they wouldn't, however, additional intersections may have to be posted.

Commissioner Miller asked if the city was still pursuing connection of Bob Billings Parkway to K-10; Woosley advised that they were as far as he knew.
