Chair Ken Miller called the meeting to order at 7:00 p.m. in the City Commission Room, City Hall, 6 E. 6th Street.

ITEM NO. 1:

<u>ITEM NO. 2:</u>

Discuss prioritization of traffic safety projects.

Public comment:

Davis Loupe, 2205 Riviera Drive: For the last year I have been walking with my son to and from school most days. One of the issues I really started thinking about was crossing Clinton Parkway and the north-south crosswalk markings being worn-out. We don't have bus service and there are a lot of students walking to school; I think there would be more if it were a safer intersection. I looked into when crosswalks were re-marked and found out it was a budgetary issue and they are re-marked when funds are available. My concern is that the intersection is not safe with the deterioration of the markings and I would like for my son to be able to walk to school on his own. We need to have a well

maintained crosswalk so the students know where to walk. In addition, the stop lines are gone and motorists don't know where to stop. I don't want anyone to get hurt at this intersection. I think an existing traffic safety feature should be maintained in its original form and should be prioritized.

Commissioner Woods asked if the intersection was controlled by a traffic signal that would stop traffic and permit pedestrians to cross; Woosley advised that it is.

Commissioner Miller asked what the priorities were for pavement markings; Woosley advised the number one priority was officially designated school crossings.

Commissioner Ziegelmeyer asked what the annual pavement marking budget is and what the cost would be to mark the crosswalk; Woosley advised that the annual budget is approximately \$15,000 and the material to mark the two north-south crosswalks at this intersection would be approximately \$1500; in addition, Woosley advised that both crosswalks would be re-marked this year.

Commissioner Woods requested that the timing for north-south pedestrian traffic be checked; Woosley advised that would be done.

Mr. Loupe thanked the Commission for taking the time to discuss the situation.
