Occupancy Guidelines in Single-family Zoning Districts

You, the tenants of _	are occupying a dwelling located in a single-
family zoned district.	You must, at all times, adhere to the occupancy guidelines set forth by
the City of Lawrence	Code section 20-202(g).

In RS, Single-Dwelling Residential Districts, a Dwelling Unit shall only be occupied by a Family as defined in Section 20-1701, Family (1), (2) or (3).

Definition of Family: (1) A person living alone; (2) two or more persons related by blood, marriage, or legal adoption; (3) in an RS Zoning District, a group of not more than three persons not related by blood or marriage, living together as a single Housekeeping Unit in aDwelling Unit, as distinguished from a group occupying a Dormitory, Boarding House, lodging house, motel, hotel, fraternity house or sorority house; or (4) in a Zoning District other than RS, a group of not more than four persons not related by blood or marriage, living together as a single Housekeeping Unit in aDwelling Unit, as distinguished from a group occupying a Dormitory, Boarding House, lodging house, motel, hotel, fraternity house or sorority house.

The above code section means that at no time during your residency may the dwelling be occupied by more than three (3) people UNLESS ALL PARTIES ARE RELATED.
