

ORDINANCE NO. 7152

AN ORDINANCE LEVYING THE MAXIMUM ASSESSMENT ON LOTS, PIECES AND PARCELS OF LAND IN THE CITY OF LAWRENCE, KANSAS, TO PAY THE COSTS FOR IMPROVING THE PARKING LOT IN THE 800 BLOCK, BETWEEN NEW HAMPSHIRE AND RHODE ISLAND

WHEREAS, the Governing Body of the City of Lawrence, Kansas (the City), by Resolution No. 6051 authorized the construction of improvements to the parking lot in the 800 Block, between New Hampshire and Rhode Island under the authority of K.S.A. 12-6a01, et seq.; and,

WHEREAS, Resolution No. 6051 established that the maximum special assessment be assessed prior to construction; and,

WHEREAS, Resolution 6051 identified the area being assessed as:

Lots 1 through 116, on Vermont Street in the City of Lawrence Original Townsite;

Lots 1 through 116, on Massachusetts Street in the City of Lawrence Original Townsite;

The odd numbered lots from 1 through 115, on New Hampshire Street in the City of Lawrence Original Townsite;

Lots 17, 19, and 21, on 11th Street, formerly Quincy Street, in the City of Lawrence Original Townsite;

Lots 1 through 13, on 6th Street, formerly Pinckney Street, between Kentucky and New Hampshire in the City of Lawrence Original Townsite;

Lots 14, 16, 18 and 20, on New Hampshire in the City of Lawrence Original Townsite;

It is expressly understood that any land owned by the City of Lawrence is excluded from this improvement district.

WHEREAS, pursuant to K.S.A., 12-6a09, subsection (c), the maximum amount of assessment has been determined for each lot, piece or parcel of land deemed to be benefitted by the improvements in the city of Lawrence, Kansas; and

WHEREAS, the City assumed the assessment cost of all properties within the benefit district which complied with the parking requirements of the C-4 Zoning District provided the property owner petitioned the City for such adjustment prior to the adoption of this Ordinance; and,

WHEREAS, the Governing Body has determined that the total estimated cost of the improvement is three hundred thousand dollars (\$300,000.00); and,

WHEREAS, the Governing Body has determined that the maximum cost assessed to the hereinafter described lots, pieces, parcels and tracts of ground specially benefitted thereby is one hundred twenty-six thousand, five hundred thirteen dollars and four cents (\$126,513.04) and,

WHEREAS, the Governing Body did hold a public hearing on the 16th day of November, 1999, to consider the proposed maximum assessments and the hearing was closed.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

SECTION ONE: For the purpose of paying part of the cost and expense of the improvements within the property specially benefitted thereby, there shall be an are hereby apportioned, levied and assessed the maximum special assessments upon the following lots, pieces, parcels and tracts of ground liable therefor, as shown on Exhibit A attached hereto and by this reference incorporated herein and made a part hereof.

SECTION TWO: After completion of the project, the City Engineer shall certify to the City Commission the actual cost of the improvements and the actual assessments which shall not be greater than that shown on Exhibit A and the City Clerk shall then notify by first class mail the owner of any such lots, pieces, parcels and tracts of ground as shown in Exhibit A as to the actual assessments.

SECTION THREE: The owner of any property so assessed may at anytime up to thirty (30) days from the date of the City Clerk's notification referred to in SECTION TWO, pay the whole amount of the assessment against any lots, pieces, parcels and tracts of ground by making such payment to the City Clerk.

SECTION FOUR: The money so paid in full as provided above shall be applied by the City Treasurer toward the payment of the cost of the Improvements and the City Treasurer shall, after the expiration of thirty (30) days from the date of notification by the City Clerk, report in writing to the City Clerk a list of all assessments that have been paid together with the amounts thereof, and for the amount that has not been paid, bonds of the City shall be issued payable in approximately equal installments, no installment to run longer than ten (10) years.

SECTION FIVE: The sums herein certified to each lot, piece, parcel and tract of ground shall be collected in ten (10) annual installments, the first of said installments shall be placed on the tax rolls in the year certified and installment for each year thereafter for the full term of ten (10) years, and the sum so assessed and levied shall bear interest at a rate not in excess of the maximum legal rate.


SECTION SIX: The City Clerk is hereby directed to annually levy the several installments in the proper amounts with interest, in a manner and within the time provided by law; provided, however, that this section shall not apply to any lot, parcel, piece or tract of ground for which the full amount of the assessment or the amount of partial payment has been paid as provided and authorized by law.

SECTION SEVEN: Pursuant to K.S.A. 12-6a11, no suit to set aside the maximum assessments by this ordinance or otherwise question the validity of the proceedings shall be brought after the expiration of thirty (30) days from the publication of this ordinance.

SECTION EIGHT: This Ordinance shall take effect from an after its passage and publication in the official City newspaper as provided by law.


