ORDINANCE NO. 8827

AN ORDINANCE OF THE CITY OF LAWRENCE, KANSAS, ANNEXING APPROXIMATELY 20 ACRES, GENERALLY LOCATED EAST OF KANSAS HIGHWAY 10 (K-10), NORTH OF WEST SIXTH STREET, WEST OF GEORGE WILLIAMS WAY, EXTENDED, AND NORTH OF BALDWIN CREEK CITY PARK, IN DOUGLAS COUNTY, KANSAS, INTO THE CITY OF LAWRENCE, KANSAS.

WHEREAS, Fairway, LC, is the owner of record of certain real property, generally located east of Kansas Highway 10 (K-10), north of West Sixth Street, west of George Williams Way, extended, and north of Baldwin Creek City Park, in Douglas County, Kansas, the legal description of which is set forth at Section 3, *infra* ("the subject property");

WHEREAS, on September 10, 2012, the owner of record of the subject property filed with the Lawrence-Douglas County Planning Office, Annexation Request, No. A-12-00190, petitioning the City to annex the subject property;

WHEREAS, the subject property adjoins the boundary of the City of Lawrence, Kansas;

WHEREAS, pursuant to K.S.A. 2011 Supp. 12-520(a)(7), the City may, by adoption of an ordinance, annex land where the land adjoins the City and the owner of record has petitioned the City to annex the land;

WHEREAS, in accordance with City policy, Annexation Request, No. A-12-00190, was referred to the Lawrence-Douglas County Metropolitan Planning Commission for recommendation;

WHEREAS, on November 12, 2012, after giving due and lawful notice, the Lawrence-Douglas County Metropolitan Planning Commission conducted a public hearing on Annexation Request, No. A-12-00190;

WHEREAS, at the November 12, 2012, public meeting, the Lawrence-Douglas County Metropolitan Planning Commission considered the report and recommendation of City staff, entertained public comment, weighed the evidence adduced at the public hearing, and voted to unanimously (8-0) to recommend to the City Commission that it approve Annexation Request, No. A-12-00190, and annex the subject property;

WHEREAS, pursuant to K.S.A. 2011 Supp. 12-520a(f), the City may, by adoption of an ordinance, annex land without resolution, notice, or a public hearing, as generally required by K.S.A. 2011 Supp. 12-520a(a), where the owner of record petitions the City to annex the land in accordance with K.S.A. 2011 Supp. 12-520(a)(7); and

WHEREAS, at its December 11, 2012 public meeting, the Governing Body considered Annexation Request, No. A-12-00190, and the recommendation of the Lawrence-Douglas County Metropolitan Planning Commission.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:

SECTION 1. The above-stated recitals are incorporated herein by reference and shall be as effective as if repeated verbatim.

SECTION 2. The Governing Body finds that the annexation of that certain real property, generally located east of Kansas Highway 10 (K-10), north of West Sixth Street, west of George William Way, extended, and north of the Baldwin Creek City Park, in Douglas County, Kansas, the legal description of which is set forth at Section 3, *infra*, is in the public interest and that such annexation is proper under K.S.A. 2011 Supp. 12-520(a)(7).

SECTION 3. In accordance with the Governing Body's finding, the City hereby annexes into the City the following described real property, located in Douglas County, Kansas, to-wit:

A TRACT OF LAND IN THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 12 SOUTH, RANGE 19 EAST OF THE 6TH PRINCIPAL MERIDIAN. IN DOUGLAS COUNTY, KANSAS, DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF SAID QUARTER SECTION: THENCE NORTH 88°09'19" EAST ALONG THE NORTH LINE OF SAID QUARTER SECTION, 623.78 FEET; THENCE SOUTH 01°20'42" EAST, 28.41 FEET; THENCE ON A MEASURED BEARING OF SOUTH 41°21'06" EAST, AND A MEASURED DISTANCE OF 382.94 FEET; THENCE SOUTH 46°35'43" WEST, 494.32 FEET; THENCE SOUTH 61°56'31" WEST, 113.77 FEET; THENCE SOUTH 15°06'47" WEST, 83.31 FEET; THENCE SOUTH 01°37'19" EAST, 400.20 FEET: THENCE ON A CURVE TO THE LEFT HAVING A RADIUS OF 120.00 FEET, AN ARC LENGTH OF 31.00 FEET, A CHORD BEARING SOUTH 09°01'12" EAST AND CHORD DISTANCE OF 30.91 FEET; THENCE SOUTH 16°25'12" EAST, 229.08 FEET; THENCE ON A CURVE TO THE RIGHT HAVING A RADIUS OF 280.00 FEET, AN ARC LENGTH OF 358.69 FEET. A CHORD BEARING SOUTH 20°16'45" WEST AND CHORD DISTANCE OF 334.66 FEET; THENCE SOUTH 56°58'42" WEST, 111.44 FEET TO THE EASTERLY LINE OF A RIGHT-OF-WAY DEEDED TO THE STATE OF KANSAS; THENCE NORTH 33°18'55" WEST, 280.30 FEET ALONG SAID RIGHT-OF-WAY; THENCE NORTH 11°11'55" WEST, 224.43 FEET ALONG SAID RIGHT-OF-WAY; THENCE SOUTH 88°05'04" WEST, 25.00 FEET ALONG SAID RIGHT-OF-WAY TO THE WEST LINE OF SAID NORTHWEST QUARTER; THENCE NORTH 01°54'56" WEST, 1341.53 FEET ALONG SAID WEST LINE TO THE POINT OF BEGINNING. CONTAINS 19.768 ACRES.

SECTION 4. If any section, clause, sentence, or phrase of this ordinance is found to be unconstitutional or is otherwise held invalid by any court of competent jurisdiction, it shall not affect the validity of any remaining parts of this ordinance.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
