Dear Mr. Corliss:

Following up on our conversation of yesterday, Deffenbaugh Industries, Inc. ("DII") believes there are several innovative considerations available to the City of Lawrence ("City") that can result in significant savings relating to the handling of municipal solid waste ("MSW") and recyclable materials. One option involves the use of a transfer station through which MSW is moved to Johnson County Landfill and recyclables are taken to the Deffenbaugh Recycling Co. processing facility.

DII envisions a public/private cooperation between the City and Deffenbaugh in which:

- DII would design and build the transfer station
- DII and City would work together to secure the necessary permits
- City would furnish the necessary property
- City would operate the scale to track in-bound and out-bound tons
- DII would furnish all necessary loading equipment
- DII would furnish all necessary transportation equipment (tractors/trailers)
- DII would be responsible for daily operations of the facility
- DII would own the facility (land excluded)
- DII and City would agree to a 20-year term after which the facility ownership would transfer to City
- City would have option of buyout of the facility at 5-year intervals at a predetermined price
- DII would agree to a transfer and disposal rate of approximately \$20 to \$24 per ton for all MSW collected and delivered by the City to the facility
- DII would agree to hold the per ton rate for a period of 24 months

In addition to cost savings realized from the disposal costs as shown above, the proposal would also provide the City significant operational savings. For example, industry estimates are that an approximate 30% reduction in maintenance exist as a result of tipping in a transfer station as opposed to tipping in a landfill.

Such a transfer station can also provide for the collection of such materials as bulky waste items, glass, e-waste and other such difficult materials in the waste stream as may be mutually determined between DII and City.

Deffenbaugh looks forward to being able to discuss the option of a transfer station in greater detail in the near future. Again, please feel free to call on us at any time.
