## **PUBLIC ACCESS EASEMENT**

THE UNDERSIGNED, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, hereby grant, sell, convey and deliver unto the City of Lawrence, Kansas, a municipal corporation, a permanent Public Access Easement for any and all public purposes, including but not limited to the construction, maintenance and use for street, curb and gutter, utility, drainage, sidewalk, pedestrian access, traffic signalization, street lights and related facilities over, under and across the following described property in the City of Lawrence, Douglas County, Kansas to-wit:

Commencing at the Southwest corner of the Southwest Quarter (SW ½) of Section 32. Township 12 South, Range 19 East of the Sixth Principal Meridian in Douglas County, Kansas; thence North 02°40'19" West on the West line of the Southwest Quarter (SW 1/4) of said Section 32, a distance of 995.23 feet to the intersection of the centerline of Bob Billings Parkway projected and the West line of the Southwest Quarter (SW 1/4) of said Section 32; thence North 88°02'10" East on the centerline of Bob Billings Parkway projected, a distance of 1981.35 feet; thence North 01°57'50" West a distance of 50.00 feet to the North Right-of-way line of Bob Billings Parkway for the Point of Beginning; thence North 75°15'52" West, a distance of 104.40 feet; thence North 01°57'50" West a distance of 20.00 feet; thence South 88°02'10" West, a distance of 50.00 feet; thence South 01°57'50" East, a distance of 30.00 feet; thence South 88°02'10" West, a distance of 119.04 feet to the proposed North Right-of-way line of Bob Billings Parkway; thence South 75°48'16" East on the proposed North Right-of-way line of Bob Billings Parkway, a distance of 71.88 feet to the Existing North Right-of-way line of Bob Billings Parkway; thence North 88°02'10" East on the existing North Right-of-way line of Bob Billings Parkway, a distance of 200.00 feet to the Point of Beginning containing 5690.45 Square Feet more or less all in the city of Lawrence, Douglas County, Kansas, subject to Rights-of-way, Easements and Restrictions of Record

The above described public access easement shall be used for any purpose that right-of-way allows, provided the public access easement shall not be construed as right-of-way for setback purposes and periphery boundaries.

Grantor shall do or cause nothing to be done to interfere with the Grantee's rights of use of said easement for the purposes herein stated.
