Dear Council Members,

It is a great privilege to write this letter of support for the application regarding the Lawrence Cultural District. I view this as exciting from my perspectives as both an architect, teaching at KU and editor of the book <u>Culture-Meaning-Architecture</u>, and as a School Board member. From these perspectives, this is an intriguing application on two fronts. First, the clear effort to leverage multiple efforts integrated by the eternal spirit of Lawrence to exemplify the idea of "an ever more perfect union." When we take a look at the timeline of Freedoms Frontier, there is a clear sense of trajectory from Lewis and Clark through the Civil War struggles of the mid-19<sup>th</sup> century up through Brown vs. Board of Education and to today. There becomes this compelling link between journey, discovery, freedom and opportunity—the pillars of the American experience. This proposal paints an evocative vision of taking this Freedoms Frontier themes and engaging them in our contemporary condition in a compelling fashion. As an educator, historical themes can all too often be examined retrospectively, and this proposal suggests an exciting way in which to bring those themes alive and illustrate their continued salience today.

Second, as a School Board member, the educational dimensions of the proposal are quite clear and are particularly relevant to two major initiatives and our three guiding principles in the school district. The Board of Education of USD 497 has organized our mission around the themes of excellence, equity and engagement. I believe this proposal shares those same core values. In specific, we have attempted to shape in our recent bond issue an expression of these values in the physical plant of our schools. This proposal links quite directly to our oldest school, New York Elementary and its significant cultural history, but also at the southern end of the Burroughs Trail to our newest educational extension of the College and Career Center at 29<sup>th</sup> and Haskell. I view public education as embodying the American vision that links discovery, opportunity and liberty and therefore I could not be more excited to see this particular project come to fruition.

I sincerely hope the Conservation Council will choose to fund this proposal which captures and exemplifies the spirit of connection: the historical and contemporary, place and meaning, education and liberty.

I am particularly taken with the idea of a coherent urban plan for the cultural district and the trail extension. In the past the city of Lawrence and a number of civic groups have placed a limited number of markers and plaques and these, while valuable, have been largely uncoordinated as to style and placement. To have a comprehensive plan of signage and markers would greatly improve the experience of our heritage for citizens and visitors alike.


