I Steve Glass called the meeting to order. Everyone introduced themselves and welcomed Jeff Vitter to the Governing Board.

II Public Comment: None.

III Consent Agenda: The Consent Agenda included the December 2, 2014 Minutes, Financials and CEO Report.

David explained that most electronic health records have a lifetime of 3-7 years. BrightEHR, the electronic health record that we own has hit 7 years. We have a plan and budget in place for continuing work with BrightEHR along with colleagues. This year each of the 5 CMHC's would pay a consortium fee of \$65K and an additional \$45K in 2016. The developed plan of action will allow us to continue our medical record goals for the next two years including connection with KHIN and the development of continued health record improvements. We have written off 2 years of receivables in BrightEHR for use of their time. The Executive Committee approved David's action with the write off at their meeting on Thursday, January 22, 2015. David added that the situation with the legislature changes daily. He will keep the group updated as he can. Medicaid expansion continues to be an uphill battle.

Both women are strong advocates for Bert Nash CMHC and continue to provide service & resources to this organization. After group deliberation, an individual vote was taken for each candidate.
