Dear City and County Commissioners:

I am contacting you to encourage budgetary support for the Dwayne Peaslee Technical Training Facility.

Development of this facility and the programming within will begin to address the need to develop a county-wide vocational and technical training center. Existing businesses have conveyed concerns regarding the lack of technical skills and workforce development in Lawrence and Douglas County for over a decade. Skillful leadership, on behalf of business and industry, has brought together educational partners at an unprecedented level. With your support we can realize the goals set in the Lawrence and Douglas County comprehensive plan and positively impact our community.

In 2004 the Policy Research Institute at the University of Kansas conducted a technical training needs assessment of the Lawrence community. Close to 200 local firms who were likely to hire technical employees participated in the study. These employers indicated the need for technical training in the Lawrence and Douglas County area. One-third of employers indicated that the gap between business needs and employee skills harmed their profitability and prevented them from expanding. The report concluded that a lack of a technical training center and reliable sources of information were limiting the opportunities for Lawrence and Douglas County economically and individually.

At the time, the report cautioned that it was unlikely that post-secondary technical training institutions in other counties would bring programs to Douglas County. That landscape has changed. With the advent of SB 155, which provides tuition assistance, transportation reimbursement and certification incentives for secondary students and adult students without a diploma, post-secondary institutions are compelled to bring programming to the Lawrence area. It is a unique opportunity to have not one, but three, post-secondary institutions looking to expand their technical training options in the shadow of a nationally recognized research university. While today's planned programming may not reflect a synergy between all four institutions, continued academic research will need technical support, and in years to come the Dwayne Peaslee Center, in collaboration with the Bioscience & Technology Business Center, will be a powerful economic driver.

This collaboration will not only help our economy, but will also help individual citizens. Unfortunately, median household income is lower on average in Douglas County than across the state of Kansas, with some areas of the county where the people living in poverty is higher than 20%. The 2013 Douglas County Community Health Plan cited strong community concern related poverty and local access to education and skills training as they set a goal to increase the percentage of adults who have an industry-recognized credential by 5%. Without a place to prepare and earn these credentials it will be a challenge to meet this goal. The Dwayne Peaslee Center will provide education and training to prepare people for good-paying jobs so they can support their families and increase the health of Lawrence and Douglas County.

The Dwayne Peaslee Center is an important part of economic and community health of Lawrence and Douglas County. I hope you will provide support for this unique facility allowing many community members the opportunities to grow.

We consider Dwayne Peaslee Technical Center an important and valuable partner to MAMTC. As the NIST Manufacturing Extension Partnership (MEP) for the State of Kansas, we receive federal funds to support the sustainability and growth of manufacturing in Kansas.

MAMTC believes that the Peaslee Technical Training Center facility is vital to supporting the growth of existing manufacturers as well as attracting new manufacturing companies to the Lawrence/Douglas County region. This is because there are currently very few workforce skills training programs for manufacturing in the region. As we work with manufacturers across the state and across the NIST MEP network, one of the top needs that manufacturers consistently report is the need for skilled workforce. We see manufacturers choose to relocate from areas that do not have trained and skilled workforce available.

From an economic development perspective, the retention, attraction and expansion of manufacturing in the region is vital to the health of the community. Manufacturing is no longer "dirty work" in dark facilities. These are good paying, highly skilled jobs that provide stable and solid career paths to workers. I am writing to you today to ask for your support in the establishment of the Dwayne Peaslee Technical Training Center located at 2920 Haskell Avenue. Establishment of an area training center has been discussed for many years and is needed now more than ever.

As a local commercial construction firm with over 90 years of business experience in the Lawrence and Northeast Kansas region I cannot remember a period where the lack of skilled trade members of the regions workforce has been in such a critical state.

Through the course of my career I have witnessed shop programs in the local schools being replaced with computer labs and standard classrooms to the level where students today are never exposed to any kind of "hands on" experience that is required to perform tasks in many different industries still. 
