Subject: Permanent Street Sign for 15 Min Parking Zone – 905 Rhode Island (SE Bldg. front door)

Dear Mr. Corliss:

The Social Service League is currently moving back to our former location at 905 Rhode Island after being away from our property while the Marriott was being built.

One of the things we have done to help streamline our operation and reduce thrift store clutter is to establish a designated receiving and sorting area in our 905 Rhode Island's southeast building. With an increase in alley traffic inevitable due to the Marriott's usage, we want to be able to accept donations from both the west (alley side) door and our (east front) door. The problem with the east front door is that it means donors may have to pull up and leave their cars idling in the street as they rush in with a box of donations.

With that dilemma in mind, we would like to respectfully request that a parking sign be put up on the street easement that reads something like:

15 min. Drop off Zone
SSL Thrift Store
9:00am-6:00pm Tues-Sat

We envision the sign to be a standard sized street sign, and we would like to have it posted indefinitely.

If there is anything we should do to help this effort along, please let me know. With the store opening next week, we are anxious to have a smooth flowing system in place as soon as possible.

LOADING ZONES

LOADING ZONES. Loading zones are hereby established in the following locations:

Connecticut Street	East side, 259 feet south of 7th Street to 268 feet south of 7th Street
Greever Terrace	South side, Louisiana Street to Virginia Street
Haskell Avenue	East side, between the curbline of Haskell Avenue and the sidewalk adjacent to East Heights School
Hilltop Drive	West side, Harvard Road to the north line of Hillcrest School
Kentucky Street	East side, 10th Street, south 75 feet
Kentucky Street	West side, 110 feet north of 8th Street, north 135 feet
Maine Street	West side, 200 feet north of 4th Street, north 400 feet
Massachusetts Street	West side, 30 feet north to 26 feet south of the entrance walk to the South Park Recreation Center; 17th Street, south 80 feet (6 p.m. to 7 a.m., and Sundays)
New York Street	East side, 10th Street to the south property line of St. Luke's A.M.E. Church (except on Sundays)
North 7th Street	East side, Elm Street to Walnut Street
10th Street	South side, 97 feet east of Kentucky Street, east 25 feet
22nd Street	South side, from Ousdahl Road west 350', 8:00 A.M. to 9:00 A.M. and 3:00 P.M. to 4:00 P.M. on school days. (Ord. 8596; 12/7/10)
