CONDITIONS OF APPROVAL

- Special Event Permit must be displayed on site during hours of operation.
- b. Temporary sign permit must be obtained from Development Services if temporary signage is to be used.
- c. Maintain an access aisle from ADA parking spaces to building door
- d. Display area, tent or structure may not be within 25' of public right-of-way and 20' away from the building
- e. Cars, trucks, vans, trailers may not be used for sale of merchandise. Parking to be located in the northeast lot.
- f. Vehicles used for storage of merchandise for event may only be on site during the approved hours of operation.
- g. Trash receptacles or other sanitation provisions, as needed.


Conditions Related to Tents

- h. The tent or other membrane structure must meet the International Fire Code.
- i. Smoking is not permitted in tents or membrane structures. 'No Smoking' signs shall be conspicuously posted and enforced.
- j. Open flame or devices emitting flame, fire or heat or any flammable or combustible liquids, gas or other cooking device shall not be permitted inside or located within 20 ft of the tent or membrane structures while open to the public.
- k. 2A10BC Portable fire extinguishers shall be provided on site.
- Two points of egress with a minimum width of 72" each must be provided as well as exit signs and emergency lighting for enclosed tents.
- m. Tents over 200 sq ft shall be located further than 20 ft from buildings or structures Maximum occupancy for tents 20' by 20' shall not exceed 27 people
