For the last 12 months (October 2014 - September 2015), the City has collected 5,317 tons of single-stream recyclable materials and 2,730 tons of source-separate recyclable materials (community drop-off bins for cardboard, newspaper, mixed paper and glass in addition to commercial cardboard and office paper recycling).

Calculations for 2014 and 2015 were completed in accordance to the contract and its addendum.
