

AMENDING AGREEMENT

This Amending Agreement is entered into as of effective date below, by and between the Customer ("Customer") identified above and **Paymentus Corporation**, a Delaware Corporation ("Paymentus").

WHEREAS:

- A The parties entered into a Master Services Agreement dated May 24, 2011
- B The parties now wish to amend Schedule A of the Master Services Agreement to change the Paymentus Service Fee Model from Convenience Fee (User Pay) to an Absorbed Model (Customer Pay)
- C The parties now wish to amend the Term (Section 9.1) of the Master Service Agreement to extend the current contract term to September 30, 2020. At the end of the Term, this agreement will automatically renew annually for a period of one (1) year unless either Customer or Paymentus provides the other party with not less than three (3) months prior written notice of intent not to renew.
- D The parties now wish to add Schedule B to disclose additional optional services being made available to the Customer with the corresponding Paymentus Service Fee, where applicable.

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, hereby covenant and agree as follows:

Except Schedules A and B, and Section 9.1. ("Term") as provided in this Amending Agreement, all provisions of the Master Service Agreement remain in full force and effect, un-amended.
