Judy opened the meeting by introducing our <u>speaker Shannon Oury</u> from the Lawrence Douglas County Housing Authority. Following is a summary of Shannon's presentation. Attached is the handout for the LDCHA Housing Programs. If you follow the sections of the handout, the remarks below will be easy to follow.

Section 8 Housing – participants need 3 years of a good rental history.

Douglas County Housing – is a moving to work program. There is a work requirement of 15hr/wk unless in an education program. Disabled and seniors are exempt from the work requirement.

Transitional housing lasts for 24 months, then the client moves to regular Section 8 housing. The moving to work clients can do activities with HUDE approval.

The waiting lists are 400 clients long for public housing and section 8. Requirements are income based. 30% of area median income. 80% are 50% and below in income.

Wyndam Place and Prairie Commons have vouchers attached to the unit not the tenant.

In 2016 funds from city \$100K and county \$50K came to LDCHA to assist families out of the housing program to their own.

<u>Question from the group</u>: The biggest housing need – mental illness – needing supportive housing and a crisis center. The center needs an exit strategy to move people to more independent housing.

<u>Guest Brian Jiminez</u> from the Code Enforcement department of the City. He also works with the planning development services. Regarding rental inspections, all rentals are licensed and require a local agent. Usually a 10% random sampling of an apartment complex is inspected.

There is a tenant complain department and Brian supplied his direct phone number: 785-832-3111. Brian deals with many different codes: general property maintenance codes, building codes that change, international codes. Accidents can cause major stress to his department and the community.
