## Policy

- Diversity goal
- Partial term will not count toward term limits
- Orientation
- Bylaws require
   Commission approval
- Boards should have email list and post agendas ahead of meetings
- Regular full and parttime employees cannot serve as voting members on boards to avoid potential conflict of interest
- Opportunity for public comment should be provided at advisory board meetings

#### **Term Limits**

- Lack of consistency with term limits
- Pros: help promote diversity of opinions and ideas and maximize number of people involved with local government
- Cons: Loss of experience and possible challenge finding qualified board members

- Joint Economic Development Council (JEDC) and the Public Incentives Review Committee (PIRC)
- Lawrence Alliance and the Human Relations
   Commission
- Funding Recommendation Boards Social Service Funding Advisory Board and Transient Guest Tax Program Advisory Board.
