The Board of Commissioners of the City of Lawrence met in regular session at 5:45 p.m., in the City Commission Chambers in City Hall with Mayor Soden presiding and Vice Mayor Boley, Commissioner Amyx, Commissioner Herbert and Commissioner Larsen present.

A. RECOGNITION/PROCLAMATION/PRESENTATION:

- 1. Recognition of Debbie McCarthy's 21 years of service as the Director of Visitors Services at the Lawrence Visitor's Center.

B. CONSENT AGENDA:

D. REGULAR AGENDA ITEMS:

2. Consider an appeal of staff's determination on Site Plan SP-17-00192, and consider approving a revised site plan, as submitted by the applicant, that adds ten (10) parking spaces for the construction of two (2) new Greek houses (*Fraternity House* use) located on property described as Lot 2, Sigma Nu Addition No. 2, located at 1500 and 1503 Sigma Nu Place, SP-17-00192.

Commissioner Larsen recused herself from the discussion.

The City Commission declared ex-parte communications.

Sandy Day, Planner II, presented the staff report.

Moved by Commissioner Amyx, seconded by Commissioner Herbert, to approve revised Site Plan SP-17-00192, as submitted by the applicant, that adds ten (10) parking spaces for the construction of two (2) new Greek houses (*Fraternity House* use) located on property described as Lot 2, Sigma Nu Addition No. 2, located at 1500 and 1503 Sigma Nu Place, SP-17-00192 with the condition to mitigate the impact of the additional parking spaces on the stormwater system through stormwater best management practices. Motion carried unanimously.

b) Consider adopting on first reading, Ordinance No. 9396, repealing the Joint Economic Development Council, and consider adopting on first reading, Ordinance No. 9397, assigning the former Joint Economic Development Council's responsibilities to the Public Incentives Review Committee and removing the Mayor and Vice Mayor from service on the Public Incentives Review Committee.

Diane Stoddard, Assistant City Manager, presented the staff report for item 4(b).

Moved by Mayor Soden, seconded by Commissioner Larsen, to adopt on first reading, Ordinance No. 9396, repealing the Joint Economic Development Council and Ordinance No. 9397, assigning the former Joint Economic Development Council's responsibilities to the Public

Incentives Review Committee and removing the Mayor and Vice-Mayor from service on the Public Incentives Review Committee. Motion carried unanimously.

E. COMMISSION ITEMS:

Commissioner Herbert read a statement regarding a future commercial recycling program and requested a work session to discuss the issue.

Vice Mayor Boley asked for information about re-routes of transportation and how those are conveyed to the public.
