Community Development Advisory Committee: Appoint Robert Baker to a term that expires 09/30/20.

eXplore Lawrence: Reappoint Derek Felch, Doug Banks and Charles Persinger to additional terms that expire 12/31/20.

Public Transit Advisory Committee: Reappoint Heather Thies to an additional term that expires 12/31/20.

- 6. Bid and purchase items:
 - Approve the purchase of two (2) Scorpion Automated Side Load Refuse truck from Chastang's Bayou City Auto Car, in the amount of \$497,996.62, utilizing the HGAC cooperative purchasing contract. This purchase is part of the 2018 CIP (PW18F11CIP and PW18F3CIP) replacement schedule.
 - b) Authorize the City Manager to execute a contract with e-Builder Inc. in the amount of \$363,000.00, for implementation services and a one-year unlimited license agreement for Capital Project Management Software, Project No. UT1706.
 - c) Authorize the City Manager to execute Change Order No. 5 with Crossland Heavy Contractors for the Clinton Water Treatment Plant Phase 1 Improvements Project UT1209 increasing the construction contract by \$4,698.00 and allowing 30 days for installation of the mixers after mixer delivery.
- 7. Adopt on second and final reading, the following ordinances:
