## **ORDINANCE NO. 9456**

AN ORDINANCE OF THE CITY OF LAWRENCE, KANSAS, AMENDING CHAPTER XVII, ARTICLE 5, SECTION 17-501, PERTAINING TO MAJOR OR MAIN TRAFFICWAYS, DESIGNATING LOUISIANA STREET, WITHIN THE CORPORATE LIMITS OF THE CITY, AS A MAJOR OR MAIN TRAFFICWAY, AND REPEALING EXISTING SECTION 17-501.

## BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LAWRENCE, KANSAS:
