Sealed bids for this work will be received **until 2:00 p.m. on the 23<sup>rd</sup> of October, 2018, at the Office of the City Clerk - 3rd Floor, City Hall, 6 East 6th Street (6th & Massachusetts), Lawrence, Kansas.** The envelope containing the bid should be clearly marked **BID NUMBER: B#####** corresponding to listing above.

All prospective bidders are advised that no bids on this work will be accepted by the Department of Planning and Development Services unless the bidder has viewed the properties to be weatherized in the company of a representative of said department.

**All bidding contractors will meet for a pre-bid conference at 9:00 a.m., Tuesday October 11, 2018. Bid documents will be distributed at that time. Immediately following the pre-bid conference, the Storm Window contractors will do an address-by- address viewing of the properties that will receive storm windows.**



Bids will be opened in the City Commission Room on the first floor of the City Hall after **2:05 p.m., October 23, 2018.**

Bids may be held by the department for a period not to exceed thirty (30) days from the date of the opening of bids in order to allow time for reviewing the bids and investigating the qualifications of the bidders prior to awarding the contract.

*The contractor agrees that the contractor shall observe the provisions of the Kansas Act Against Discrimination and shall not discriminate against any person in the performance of work under the present contract because of race, religion, color, sex, disability, national origin or ancestry. The contractor shall in all solicitations or advertisements for employees include the phrase, "equal opportunity employer."
