Dear Ms Riedemann,

The following signatures are from 251 property owners opposed to the Queens Road project.

Signatures are strictly those of property owners included within district boundaries and do not include an equal or greater number of signatures from renters similarly opposed but, whose properties are owned primarily by entities controlled by 4 separate owners, none of which were responsive to inquiries. As a note of interest, while a number of homeowners did not answer their doors after numerous attempts, only 3 were uninterested in signing the petitions. Notably, either because they felt "no protest agreements" prevented them from signing or, because they had business relationships with the City.

In this regard, please find attached, one set each of protest petitions for the "improvement districts" authorized by Resolution 7267 at the public hearing of October 2, 2018 and commonly referred to as; 1) the "Queens Road Benefit District", and 2) the "Queens Road and 6th Street Benefit District". Since your office indicated specific forms and instructions for such protest petitions were not available from the City, they were prepared in accordance with the general guidelines contained in KSA 12-6a06 and are being filed on or before the close of business, November 12, 2018, as instructed.

We are unaware of how the City moves forward from this point and appreciate any guidance you can provide regarding procedures, key events and schedules, as well as the result of your findings after reviewing the attached. Thank you, your staff and others for your effort and responsiveness to this and prior communications and please let us know if we can provide any additional information or answer any questions.

## HOW TO PROTEST A REZONING OR SPECIAL USE PERMIT IN THE CITY OF LAWRENCE

If you own property which lies within 200 feet of a proposed Rezoning or Special Use Permit (SUP) located in the City of Lawrence and you oppose the rezoning or SUP, you may file a protest petition in opposition to it.

If the petition is found to be valid, approval of the rezoning requires a ¾ vote of all of the members of the Board of City Commissioners present and voting on the matter, rather than a simple majority.

- A. For a protest petition against a rezoning (or SUP) to be valid it must meet the following requirements:
  - 1. It must be signed by the owner or owners of 20% or more of the real property within the area required to be notified of the rezoning (or SUP), excluding streets and public ways, (generally meaning property within 200 feet of the land for which the rezoning (or SUP) has been proposed).
  - 2. It must be filed with the City Clerk before 5:00 p.m. on or before the 14th day after the date of the conclusion of the Planning Commission public hearing. The day following the Planning Commission shall be counted as the first day. If the 14<sup>th</sup> day falls on a weekend or holiday, the Petition must be filed before 5:00 p.m. on the first business day following that weekend or holiday. The City Clerk's office is located in City Hall, 6 E. 6<sup>th</sup> Street, P.O. Box 708, Lawrence, KS 66044.
- B. Facts about the petition:
  - 1. The "owner" for the purpose of a protest petition is defined as the owner of record (according to County ownership records) on the date of publication of the legal notice for the Planning Commission public hearing. The "owner" of property being purchased on contract is the contract seller.
  - 2. Each and every owner of a single piece of property must sign the protest petition, but all are considered as a single owner in determining the sufficiency of the petition.
  - 3. An authorized representative of a corporation or other legal entity may sign, but may be required to provide a legal documentation of his or her right to sign for the corporation or other legal entity.
  - 4. The protest petition should state what is being protested and the real estate's general location.


