I. CALL MEETING TO ORDER: Determine quorum of members.

II. Introductions

III. Approve August meeting minutes. Approved with spelling corrections. Motion by Steinle, second by Nimz. Motion passed.

#### IV. SAB administrative items

- a. Introduction of Jessica Lee. Lee was appointed to fill an unfilled seat that expires 12/31/18. Lee is eligible for reappointment at that time if interested.
- b. City staff changes and SAB. The City of Lawrence recently merged the Utilities and Public Works Departments, forming a new Municipal Services Operations (MSO) Department. In the past, staff from Public Works have served as consistent staff support for SAB. Moving forward, the Sustainability Office will continue to serve as the staff liaison. Staff from other departments, including MSO, will continue to serve as resources to SAB, but will not be in attendance at every SAB meeting.

#### V. Discussion: Landfill Tour reflections

- a. Several members of the Food Policy Council food waste reduction working group attended a tour of the Material Recovery Facility on September 10.
- b. Reflections included Discussed plastics markets and the challenge with China
- c. Several types of plastics are harder to find markets. The US will need to rethink recycling and cannot expect to ship things out of the country.
- d. Charlie Sedlock, Vice President, Hamm Waste Services offered to come to the October SAB meeting to present on the methane capture system at the landfill.

- a. Report from Sharon Ashworth. The committee is focused on green stormwater infrastructure and hopes to identify a pilot project in the Capital Improvements Plan. It may be beneficial to convene staff from Shawnee County, Johnson County, and KU in Lawrence to consider the possibilities of green infrastructure. KU has a green infrastructure demonstration project.
- b. Reactions to using the 90/90 tool: it was valuable to think about what is possible in 90 days. Challenging because there are so many unknown pieces.
- c. Jessica Lee will join the Water Committee

## VII. Update on Single Use Plastic Committee

- a. SAB members of the subcommittee will meet before the next SAB meeting to determine a research and engagement.
- b. SAB will work with a masters level fall course at KU to conduct research and policy analysis.

- d. Steinle would like to reconnect with the Retail Grocers Association, who attended the August SAB meeting, to see if the Kroger announcement has changed the discussion in the industry.

### VIII. Staff Report

- a. The stream buffer text amendment, presented to SAB in August, <u>was</u> <u>approved on Aug 21</u> by the City Commission. This directs staff to develop an ordinance that will outline a process to permit and review development in relation to stream corridor protection.
- b. City of Lawrence Common Ground Program is celebrating 7 years of community creativity, connections, and healthy, local food production! SAB members are invited to attend a tour of one or more Common Ground sites on Friday, October 5, at John Taylor Park.
- c. The Lawrence Downtown Master Plan process will begin in October with the establishment of a Downtown Master Plan Steering Committee.
- d. The Metropolitan Planning Organization need volunteers to do bicyclists and pedestrian counts on Saturday, September 15 from Noon 2

- e. The Greenhouse Gas inventory data almost complete, and entering the quality assurance phase with data partners.
