Dear Commissioners,

I am unable to attend tonight's City Commission meeting to speak during public comment on the North Mass Redevelopment Project. As such, please see my comments below. I know it's late to comment on a specific action item tonight, but I also imagine this is the first of several discussions, so I hope my comments will be useful/relevant.

I very much am in favor of building a vibrant downtown Lawrence and creating greater connections to the Kansas River, so I think development just north of downtown on the north bank of the Kansas River is potentially positive for our community. I would like to ensure that the plan adequately addresses appropriate environmental protections for the Kansas River, since the project will encroach upon this important community resource. I am concerned in large part because the planning commission staff report addresses this issue in a cursory fashion. In fact, ensuring environmental protection of the river itself does not appear to be mentioned once in the report.

This is unfortunate, because environmental protection goes well beyond drainage. An adequate natural reserve space/buffer between human developments and marine systems like rivers are known to reduce erosion, pick up excess nutrients from parking/structure run-off, and provide resources to both wildlife and residents/visitors to our community. Many river cities in Kansas with riverfront developments have proactively sought to use native plants in such "buffer spaces" because they generally perennial, are low maintenance, and can be well-suited for park purposes. Development that does not include a buffer of native green space along the river will lead to loss and pollution of soils, reduced water quality in the river, and reduced appeal to those residents who visit our city, especially those interested in the river for aesthetic and recreational reasons. At a time when we are considering other mechanisms to enhance access to the river by area residents, let's not decrease access by overlooking the opportunity to develop a useful natural/recreational corridor as part of this project.

Current plans do call for some park lands on the proposed site. At a minimum the City should ensure that land is established with native plants. Ideally, I think the plan should include expanded areas of natural lands that would serve as a vital resource for the reasons described above.

Thank you for the opportunity to provide comment.
