Description:

Sheet MP101:

- a. Revised location of 4" waste stack serving 1st and 2nd floor.
- b. Revised location of new 2"FD-2 as discussed on site (1-18-2019). Existing 3"FD nearby to be abandoned.

Sheet MP111:

- a. Revised cold water drops and cold water supply piping for fire truck fills.
- b. Eliminated floor drain in front of EES-1 in Work Room 112. Centered other floor drain in room.
- c. Provide credit pricing for removal of shower P-10. This pricing should include the fixtures, piping, pipe fittings, and labor associated with installation of the shower P-10. 2"FD-3 in this location shall remain.

Sheet MP201:

a. Revised waste piping to flow to chase on south side of restrooms.

Sheet MH101:

- a. Rerouted refrigerant purge exhaust to achieve 20' minimum from building openings.
 - a. Reduced side of purge exhaust duct from 22"ø to 16"ø.
 - b. Relocated originally specified 22"x22" CD-3 to new location.

Sheet MH111:

- a. 16"ø refrigerant purge exhaust duct located in corner of Bunker Gear Room 117.
- b. Makeup air to the Apparatus Bay has been reworked to come from DOAS-1. The prior response issued to RFI 022 is now void. DOAS-1 will now provide 500 CFM of constant, conditioned makeup air to the apparatus bay.
- c. Due to the addition of makeup air into the Apparatus Bay, EF-4 should now be turned up to its maximum speed.

Sheet MH121:

- a. Rerouted refrigerant purge exhaust to achieve 20' minimum from building openings.
- b. Increased size of duct in Mech 218 from 12x12 to 16x16 to supply makeup air into Apparatus Bay.

Sheet MC101:

a. Relocated new 2"FD-2 to a location where all condensing unit drain pans can be piped to one floor drain per discussion on site (1-18-2019). Existing 3"FD nearby to be abandoned.
