Chair Gaches called the meeting to order at 11:00 am. ENTIRE VIDEO

1. General Public Comment VIDEO

There was no public comment.

2. Review Notice of Funding Availability (NOFA) applications VIDEO

- a. Lawrence Habitat for Humanity
- b. Tenants to Homeowners, Inc.
- c. Wheatland Investments Group
- d. Independence, Inc.
- e. Lawrence-Douglas Co. Housing Authority / Family Promise of Lawrence
- f. Ohio Mortgage Investors, LLC

Gaches told the board he accidentally left out two scores when completing his scoring matrix; staff updated his scores and provided the board with an <u>Adjusted key project elements chart</u> to reflect the new scoring changes. Staff also provided a <u>key project elements chart without the construction feasibility scoring</u>, to allow the board to equalize the rating scales for both capital and non-capital requests.

Gaches reminded the board the NOFA was intentionally designed to award projects to be executed in 2019, and to consider that factor when making their funding recommendations.

3. Discuss allocations and consider making funding recommendation to the City Commission VIDEO

Gaches asked if there was any staff direction on how to proceed with the allocation discussion. Stoddard said the discussion was up to the board, using the materials provided by staff and the board's NOFA Application Process and Procedures, as a guide. Stoddard reminded the board the score for each application is just a tool, and may not be the determining factor when a recommendation is made to the City Commission.

McCullough reminded the board of the staff prepared <u>leverage calculation</u> and <u>construction feasibility</u> information.

The board discussed the applications and presentations.

Soukup suggested to defer the Ohio Mortgage Investors, LLC application, to defer the Wheatland Investments Group application but suggest they resubmit an application for the upcoming round of funding, to fund the LDCHA/FP application at least \$50,000, to fully fund Tenants to Homeowners, Inc. at \$150,000, to fully fund Lawrence Habitat for Humanity at \$50,000, and to not fund Independence, Inc.

The board discussed Soukup's suggested funding recommendations.

Howe moved to fund Tenants to Homeowners, Inc. at \$125,000; Independence, Inc. at \$25,000; Lawrence Habitat for Humanity at \$50,000; and Lawrence-Douglas County Housing Authority at \$50,000 specifically for voucher use. Guffey seconded the motion. VIDEO

The board discussed Howe's funding recommendations, including a discussion on if the housing trust funds should be used to pay for staffing.

Howe agreed to amend his motion, and moved to fund Tenants to Homeowners, Inc. at \$125,000; Independence, Inc. at \$25,000; Lawrence Habitat for Humanity at \$50,000; and Lawrence-Douglas County Housing Authority/Family Promise at \$50,000 to be used for vouchers or case management, at their discretion. Guffey agreed to second the amendment to the motion. VIDEO

The motion passed 8-0.
