Judy welcomed all attendees to the meeting and introduced our speaker and topic for the day: Bob Nugent, Transit Authority

Following is a summary of Mr. Nugent's remarks:

- Lawrence has had a transit system since 1871, first using horse drawn vehicles. Transit was run by a private concern until the 70's. In 1971, the Lawrence Bus Company, a city service ceased operation.
- KU started bus service which was funded by students and run by students.
- In 2000, the city reached 50,000 population and was eligible for federal funding with dollar matching with the feds. This occurred in 2006-7-8.
- In 2008, transit services were put on the ballot. This was a special 10-year tax.
- In 2018, another 10 years of service was voted in.

The Transit Authority is a legal framework. The city did not create this. KU and the city have coordinated without federal dollars. The city has purchased the buses, KU has created the facility.

There are 2 services available in Lawrence.

- Local service is funded with state dollars and no federal dollars. To operate the buses, must consider the cost of drivers, fuel, maintenance.
- ADA service funded with federal dollars we cannot deny service. The cost is 5 times more than the fixed route service.

Amenities – currently there are shelters and benches. Note that there has been a 250% increase in ridership since 2009.

There will be another transit survey coming up. Here is the result of the last one.

- What would be the best place to have a center? The report concluded that 21<sup>st</sup> and Stewart would be the most central location. However, the city commission wouldn't vote on it.
- Conclusion sit down with the city commission first.
- There was great neighborhood opposition to any center along 19<sup>th</sup> street.

<u>Transit in the county</u>. City does not serve the county. Discussion of regional transit involving Topeka, Lawrence, Wyandotte county and Kansas City. Transit evolves from 1-2 people to a van, to bus, to train.

Question of what LDCACA can do to support the transit efforts. Best to go to Facebook and follow the progress. <u>Lawrence Transit System</u> is the page.

<u>Care Act</u> – AARP will be setting up presentations. If we can gather 15 or more people – AARP will provide a speaker.

<u>Affordable Housing</u>- League of Women Voters program has been moved to Central Methodist Church, 1501 Massachusetts, May  $17^{th}$  from 7-8:30 pm. Panel will include Shannon Oury, Matthew Faulk and Lisa Larson.

Sidewalks and Accessibility – June speaker – David Krone and Chuck Soules were suggested as speakers.
