Mary welcomed all attendees to the meeting. She then introduced Sarah and John , speakers.

Midland Care, PACE Services – Sarah began

PACE provides an all-inclusive care for the elderly. The program was started on the 60-70's in San Francisco. The Midland/PACE program serves Douglas, Jackson and Shawnee counties. It is for those who are 55+. There are several parts to the program:

- Health Care. Components include a primary care doctor, nurse, occupational therapy, physical therapy, home support, social worker, transportation and life enrichment.
- Day Center In addition to socialization, the center offers breakfast and lunch.
- Works like an HMO with money to fund coming from many sources. If the client has Medicare and Medicaid, PACE pays all claims.

<u>John White</u> – has been with Midland for past 7 months. There are 52 clients in Lawrence with 300 clients throughout the service area. Nine different people will work with each client. He said that the only reason to turn someone away if they are unsafe in the community. The program may not be for everyone.

Questions and Answers:

- What if a person is not eligible for Medicaid. They pay a flat fee to buy in and pay the Medicaid portion (about 3-4,000 per month). This is definitely less expensive than a 24 hour nursing home. PACE currently does not offer day care to those outside of the PACE program. When people need Long Term Care, the fee is covered. Clients can dis-enroll of they can't afford the fees. They can go on Long Term Care.
- If a person is on Medicare and Medicaid, any income above \$1,177 is designated the client obligation. PACE is called a Qualified Medical Beneficiary and acts as a supplemental policy.
- People can always talk to a SHICK counselor (at the Senior Resource Center) for help in getting through the information on the many medical plans.
- Assessment questions used by PACE are one used by HCBS and KANCARE and nursing facilities. Client has to score 26 to qualify for PACE.
- The client can keep their current primary care doctor and sees them a couple time a year.
- The main physician for the Midland/PACE program is Dr. David Wensel.
- Across the country, 50,000 people are enrolled in PACE. The program is audited every two years by CMS.
- There are 2 other PACE programs in Kansas. Via Christie in Wichita and Blue Stem in western Kansas.
- PACE has contracts with providers for services that the basic program does not provide. If the PACE team determines that the client can benefit and KANCARE says it is medically necessary, hearing aids and dentures are provided.
