1. Give a <u>brief</u> narrative of the activities that were funded with City funds over the reporting period checked above.

The Willow has utilized City funds to support our outreach efforts. Our outreach efforts help survivors learn about resources, educate our community, and recruit new advocates and volunteers. We have had had an increase in both volunteer and intern interest. Examples of the outreach include, but are not limited to, Lawrence Journal World, Facebook, Yellow Pages, Website development and maintenance, and printed materials. We also used a portion of the funds on in house copying of presentation materials.

2. Provide specific detail (and supportive documents, if needed) to demonstrate progress made toward your goals/objectives.

The Willow's outreach program continues to bring awareness to our community about domestic violence. This year's focus was on men experiencing domestic and relationship violence. Our community awareness program brought three men seeking shelter and one hundred and eleven seeking services in the community setting. The Willow considers this remarkable progress. We know that 1 in 3 women will experience domestic violence, but we believe that the statistics for men are just now being compiled. The Willow is the first domestic violence center in the state to include men in their shelter services. All three men went on to safety. This would have not been possible without the printing, website and social media support and advertising this grant provides. With the City of Lawrence help, The Willow has brought essential services to an underserved population.

3. How have you impacted the citizens of Lawrence?

Through our multiple outreach efforts, we have been able to deepen the education and awareness of domestic violence and human trafficking in the Lawrence community. Additionally, we have been able to recruit incredible volunteers and advocates to help us provide lifesaving services to those experiencing domestic and relationship violence. With the City of Lawrence's help we have increased the visibility of not

only our agency but also the community conversation about domestic violence. In 2016 The Willow gave 124 presentations on domestic and relationship violence reaching over 3,000 persons. We never know when we have reached either a victim or family member or friend and saved a person's life.

- 4. What barriers, if any, have you encountered? The isolation that is inherent in domestic violence creates a barrier to accessing The Willow's outreach services. Some victims do not have phones, or access to newspapers or the internet. We are always looking for new means of communicating with victims and their families. This next year we are looking for innovative and creative ways to reach those experiencing domestic and relationship violence that are isolated and without the tools to contact us.
