The primary purpose of these funds is to help Lawrence homeless and low-income residents who cannot afford public transportation to gain access to the Lawrence public transportation service in order to keep appointments and interviews that are related to health, employment, housing, legal needs or securing benefits. These funds are distributed to 7 partnering agencies serving the homeless, including: The Willow Domestic Violence Center (The Willow), Bert Nash Homeless Outreach, East Central Kansas Action Network (ECKAN), Family Promise, First Step, DCCCA, Inc., The Lawrence Douglas County Housing Authority (LDCHA) and the Salvation Army.

3. How have you impacted the citizens of Lawrence?

Agency Name: The Willow Domestic Violence Center

The bus pass fund allows the agencies to assist individuals who are homeless with no income/very low income to have improved access to the city and service providers through transportation. Through increased transportation, the partner agencies are helping those without income secure the means to become part of the local economy through increased community engagement, employment and benefits that lead to permanent housing in Lawrence. Providing bus passes also empowers homeless individuals to utilize community resources through increased self-sufficiency.

A success story from The Willow:

This spring, a domestic violence victim staying at The Willow's shelter home worked with an advocate to gain employment. The victim's abuser had previously forbidden her from working, so she had a few job skills or experience. A Willow advocate worked with her to decide what type of work she was interested in. Together they created resumes and a plan of places to apply to. The survivor was very adamant about applying to jobs in person so she had a chance to present herself in a professional manner. The advocate helped her receive more than our usual daily allotment of bus passes to allow her to apply to as many jobs as she could quickly.

The survivor received 6 bus passes and moved between several different businesses that day. By the end of the week she had a job offer. This small investment (\$6 total) allowed the survivor to quickly gain employment and give her time to receive her first paycheck before the end of her emergency shelter stay. This job will take a family in crisis and homeless to stable and safe housing. For a mere \$6 investment, this is an incredible return.

4. What barriers, if any, have you encountered?

There have been no barriers in the identification of individuals who are eligible/served by the agencies or in the distribution of bus passes to such individuals by any of the partner agencies.

Overall, the most significant barrier to the program is that there are not enough funds to meet the need. The program partners seek methods to supplement the program so that the needs for all the clients at each agency are able to be met.
