CIS of Mid-America delivers an evidence-based model of integrated student support services to at-risk students at partner schools. A school-based site coordinator brings local resources to the school where they are accessible, coordinated and accountable. The site coordinator is a single point of contact working inside the school to connect students and families with community partners and resources addressing student needs and school-wide issues. During the 2014-2015 school year: 99% stayed in school, 89% of eligible seniors graduated, 97% were promoted to the next grade level, 88% met behavior goals, 81% met attendance goals, and 83% met academic goals.
