- C. Did you receive City funding for this program in calendar year 2015? If so, how much? \$45,000
 - 1. How would a reduction in city funding in 2016 impact the ability of your agency to provide services to/on behalf of the City? A reduction in funding for 2015 would mean that we would not have adequate funds to enable all underserved members of the community, regardless of ability to pay, to attend preschool, or take drama, dance, or visual arts classes. With more than 20% of our constituency in need of financial assistance, a reduction would negatively impact our agency as well as quality of life in Lawrence. We did not increase our request for city funding for facilities maintenance costs this year, with the hope that any increase in city funding will go directly towards need-based financial aid for children and adults.
 - 2. If you are requesting an increase in funding over 2015, please provide a justification for the increase. The Arts Center currently makes very difficult decisions in relation to providing financial aid. We have gone from 20% of our preschool families receiving financial aid to 25% in this fiscal year. We do not want to turn anyone away, but without additional financial aid support from the City of Lawrence, we will be forced to deny arts opportunities to some of the most-needy families in our community due to inability to pay. We pledge to continue to try to match city support through private fundraising. This \$60,000 request represents ½ of our financial aid needs for one year.
