

2021 Application for Special Alcohol Funding

APPLICATION INFORMATION

General Information: The State of Kansas has created an Alcoholic Liquor Fund and Charter Ordinance No. 33 describes how those moneys are to be distributed for the City of Lawrence. Pursuant to K.S.A. 79-41a04, the City shall credit 1/3 of the deposit to the General Fund, 1/3 to the Special Recreation Fund, and 1/3 to the Special Alcohol Fund. The City Commission considers requests for the allocation of 1/3 that goes to the Special Alcohol Fund to help support agencies that provide programming in accordance with Charter Ordinance No. 33 (summarized below).

Expenditures in the Special Alcohol Fund shall be used for programs, services, equipment, personnel, and capital as the governing body determines is in the best interest of the public to address one or more of the following:

a) Prevention of alcoholism and drug abuse, including but not limited to education, counseling, public information efforts and related activities; or

b) Alcohol and drug detoxification efforts and related activities; or

c) Intervention in alcohol and drug abuse or treatment of persons who are alcoholics or drug abusers or are in danger of becoming alcoholics or drug abusers: or

d) Law enforcement, prosecution, court activities and programs, or portions thereof, related to apprehending, prosecuting, adjudicating or monitoring individuals who are alcoholics or drug abusers or are in danger of becoming alcoholics or drug abusers, including individuals who are or may be charged with violating laws related to alcohol or drug use; or

e) Education, counseling, public information efforts, and related and associated activities related to preventing drug abuse and alcohol abuse, including but not limited to efforts to encourage healthy youth and family development and related efforts which include as a partial element drug abuse and alcohol abuse education, counseling, or public information efforts; or

f) Programs, activities, or efforts related to preventing or intervening in drug abuse and alcohol abuse, including programs, activities, or efforts for which drug abuse and alcohol abuse prevention or intervention comprises a partial element of the complete program, activity or effort; or

g) Any program, activity, or effort, or a portion thereof, that the governing body determines seeks to discourage, prevent, intervene, or address issues related to alcohol or drug abuse.

Applications will be reviewed by the Special Alcohol Funding Advisory Board. Following their review, the Board will make a recommendation for funding to the City Commission. Recommendations will be based on available resources, the need demonstrated through the agency's application, the stated objectives of the agency's program, past performance by the agency in adhering to funding guidelines (as appropriate), and the ability to measure progress toward the programs objectives.

Other Information. Collaboration and/or coordination between agencies is highly recommended and multi-agency proposals to address an identified community need is encouraged. All programs must have goals with measurable outcomes.

Reporting Requirements. All recipients of Special Alcohol Funding will be required to submit an annual report to the City of Lawrence outlining how the funds were used and whether the stated objectives were met by February 15, 2022.

Distribution of Funds. Funds will be distributed in two equal disbursements and in accordance with the Kansas Cash-Basis Law of 1933, codified as amended at K.S.A. 10-1101 *et seq*. The first distribution is to occur no earlier than April 1 of the grant year and the second distribution is to occur no earlier than October 1 of the grant year.

A. How is the proposed program consistent with City <u>Charter Ordinance 33</u>? Please cite specific subsections of City Charter Ordinance 33 and explain how it aligns with your program.

The primary function of the proposed program is to provide intervention and treatment for substance use disorder, meeting the criteria of subsections c and f of City Charter Ordinance 33.

Mirror' s outpatient programming includes individual and group counseling, peer mentoring, and case management. Our program utilizes and coordinates with existing mental health services, including consultation for psychiatric care. This program also partners with several community providers to ensure holistic treatment of every individual. Counselors work with clients to identify needs and barriers to recovery and, in partnership with our case manager, make the necessary referrals based on the client's preferences and needs.

Beginning in Spring 2021, Mirror plans to offer medication assisted treatment for alcohol use disorder and opioid use disorder.

Access to counselors, mental health services, case management, and medication assisted treatment ensure that the client receives care that is more comprehensive and holistic, increasing the likelihood of a successful treatment outcome.

SECTION 3. STATEMENT OF PROBLEM / NEED TO BE ADDRESSED BY PROGRAM

This program aims to serve residents of Lawrence who have been diagnosed with a Substance Use Disorder(SUD), including those with co-occurring mental health issues. Approximately 8.1 million adults in the US have co-occurring disorders (COD). This accounts for more than 40% of those with SUD (National Survey on Drug Use and Health; 2015). The prevalence of COD has led Mirror to create programs designed to reduce barriers to treatment and to provide a holistic experience for all clients. Clients to the program must meet admission criteria under ASAM guidelines for SUD treatment. This proram is for men, women, and adolescents who do not have Medicaid or other insurance coverage.

B. Please describe what demographic disparities exist, and how the program is designed to increase equity. Who would benefit from or be burdened by this program?

Treatment for substance use disorders can be cost-prohibitive, especially for individuals without commercial health insurance. This grant allocation would fully fund treatment for thirty individuals who are uninsured or underinsured. When support services and/or medications have an associated cost, Mirror works with other programs to assist with meeting those needs. Mirror has contacts within the community to provide interpretation services for hearing impaired and non-English speaking clients.

Mirror believes that anyone who desires treatment should be able to access it. We do our best in all of our programs to eliminate barriers for clients and to help find solutions that work for each individual. If we are not able to help someone, our goal is to get them into contact with an organization or program that is better suited to meet their needs.

Mirror continually evaluates community needs and outreach opportunities for all locations. With the current public health concerns regarding COVID-19, Mirror has worked hard to ensure our services remain available for clients from all backgrounds and socio-economic status. While we have greatly expanded our telehealth services, we have also continued to offer face-to-face services for clients who do not have access to reliable internet service or technology. Our "live" programs follow CDC guidelines, including health screenings (employees and clients), frequent hand-washing, social distancing, and wearing masks. Our programs have seen an increase in inquiries and admissions since the beginning of the pandemic, and our goal is to continue to expand our programs in order to meet the needs of each community we serve.

Mirror's intention is to work collaboratively with local community resources and we do not anticipate any adverse impact on the community and/or other area resources.

SECTION 4. DESCRIPTION OF PROGRAM

Mirror's outpatient program uses the Cognitive-Behavioral Interventions for Substance Abuse (CBI-SA) curriculum. As the name suggests, this intervention relies on a cognitive behavioral approach to teach strategies for avoiding substance abuse. The program places heavy emphasis on skill-building activities. Our program also follows the Living in Balance curriculum. This flexible program draws from cognitive-behavioral, experiential, and Twelve Step approaches to help clients achieve lifelong recovery. Clients work through both programs with the help of their counselor, peer mentor, and through group treatment sessions. Each client has an individualized treatment plan, and counselors help clients identify their own needs as they work towards recovery. Each client creates a personalized, workable relapse prevention plan prior to program completion.

This program aims to serve residents of Lawrence who have been diagnosed with a substance use disorder. Clients must meet admission criteria under ASAM guidelines for Outpatient Treatment. This program will serve men, women, and adolescents. Clients in this program may have a co-occurring mental health diagnosis.

F. What other agencies in the community are providing similar types of services, and how do you coordinate services?

While there are other SUD treatment programs in the area, DCCCA does not offer services for co-occurring mental health issues, nor do they offer medication assisted treatment. Bert Nash does not serve adolescents. *
